

Instruction – Digital authorisation via Studielink

Please note: you can only pay tuition fees with digital authorisation if you have a bank account from a country in the SEPA area. Which countries are in the SEPA area can be found [here](#). If someone else (eg your father/mother) will pay, they also must have a bank account in the SEPA area AND have their own DigiD (a Digital Identity for Dutch citizens).

➔ Step 1: Go to 'My To Do List' and click 'Enter your payment details'. (this is only possible after you have submitted an enrolment application).

→ Step 4: You (the student) will now receive an e-mail at the e-mail address that was entered in Studielink. In this e-mail you will find a link to the webpage where the person that will pay the tuition fees, can confirm the digital authorisation. Forward this e-mail to this person and ask them to confirm the authorisation as soon as possible. For this, the person needs their DigiD. Until the digital authorisation is confirmed you will see the To Do action 'Get digital authorisation confirmed'. Clicking this To Do Action allows you to resend the message with activation code to the person that will pay your tuition fees.
