Academic End-User
Software License Agreement

1. Paul van den Broek (hereafter referred to as LICENSOR) grant to _____ at _____ (hereafter LICENSEE), non-exclusive non-transferable license to use the “Landscape” computer software program and associated documentation (hereafter called the ‘PROGRAM’), upon the terms and conditions herinafter set out and until LICENSEE discontinues use of the PROGRAM.
2. The PROGRAM is provided to the LICENSEE at no charge.
3. LICENSEE acknowledges that the PROGRAM is a research tool still in the development stage, that is being supplied “as is”, without any accompanying services from LICENSOR and that this license is entered into in order to enable LICENSEE to utilize the PROGRAM in its scholarly and operational activities.
4. LICENSOR agrees to notify LICENSEE of any modifications, improvements, or derivatives of the PROGRAM on a release basis and to supply LICENSEE at request a copy, under the same terms of the license as granted in Article 1.
5. LICENSOR AND LEIDEN UNIVERSITY MAKE NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED. BY WAY OF EXAMPLE, BUT NOT LIMITATION, LICENSOR AND LEIDEN UNIVERSITY MAKE NO REPRESENTATIONS OR WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE AND MAKE NO REPRESENTATIONS OR WARRANTIES THAT THE USE OF THE LICENSED SOFTWARE COMPONENTS OR DOCUMENTATION WILL NOT INFRINGE ANY PATENTS, COPYRIGHTS, TRADEMARKS OR OTHER RIGHTS OF THIRD PARTIES. LICENSOR AND UNIVERSITY WILL HAVE NO LIABILITY NOR BE LIABLE FOR ANY DIRECT, INDIRECT OR CONSEQUENTIAL DAMAGES WITH RESPECT TO ANY CLAIM BY LICENSEE OR ANY THIRD PARTY ON ACCOUNT OF OR ARISING FROM THIS AGREEMENT OR USE OF THE PROGRAM.
6. LICENSEE agrees to give academic credit, including but not limited to citations and references as prescribed by the American Psychological Association’s Manual, to Paul van den Broek and Yuhtsuen Tzeng in all public communications, including but not limited to publications and presentations at professional meetings, involving the PROGRAM and any modifications, improvements, or derivatives of the PROGRAM.
7. LICENSEE agrees to notify LICENSOR of any modifications, improvements, or derivatives of LICENSEE makes to PROGRAM and to supply LICENSOR upon request with a copy of same. Licensee hereby grants LICENSOR an exclusive license, with the right to sublicense, to any modifications, improvements, or derivatives of the PROGRAM that LICENSEE may develop, free of charge.
8. Ownership of all rights, including copyright in the PROGRAM and in any material associated therewith, shall at all times remain with LICENSOR and LICENSEE agrees to preserve same. LICENSEE agrees not to use any portion of the PROGRAM in any machine-readable form outside the PROGRAM, nor to make any copies except for its internal use, without prior written consent of LICENSOR. LICENSEE agrees to place the appropriate copyright notice on any such copies as follows: “© Paul van den Broek, Leiden University, and Yuhtsuen Tzeng, National Chung Cheng University. 9. This agreement shall be construed, interpreted and applied in accordance with the laws of The Netherlands. This agreement is the complete and entire AGREEMENT of the parties with respect to its subject matter. No purchase order from LICENSEE will be accepted by LICENSOR that contains terms and conditions other than are contained in this AGREEMENT.
10. Nothing in this AGREEMENT shall be construed as conferring to LICENSEE any right to use in advertising, publicity or otherwise any trademark of the LICENSOR or the name of LICENSOR.
